I understand and agree that medical or other services rendered to me/my child by or at the insistence of any of the above parties is not an admission of liability to provide or continue to provide any such services and is not a waiver by any said parties of any hereunder. I also acknowledge that should I/my child require transport to a medical facility, I must pay for such transportation and any treatment, period. I further agree now and forever to hold the above named and unnamed parties harmless and indemnify them for all claims, damages, judgments and costs of whatever nature and form.

I hereby give Daniel Hedman d/b/a Faster Athlete the absolute right and permission to publish, copyright and use my/my child's name and photographic likeness in all forms and media for advertising, trade, and any other lawful promotional purposes with the understanding that such images will never be sold or shared with any other organizations in any way.
